DEBTORS' MOTION FOR ENTRY OF INTERIM AND FINAL ORDERS
(I) AUTHORIZING THE DEBTORS TO PAY CERTAIN PREPETITION TAXES
IN THE ORDINARY COURSE OF BUSINESS AND (II) AUTHORIZING BANKS
AND FINANCIAL INSTITUTIONS TO HONOR AND PROCESS CHECKS AND
TRANSFERS RELATED THERETO

The debtors and debtors-in-possession in the above-captioned cases (collectively, the "Debtors") hereby move (the "Motion") pursuant to sections 105(a), 363, 507(a)(8) and 541 of title 11 of the United States Code (the "Bankruptcy Code") and Rule 6003 and 6004 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules") for an interim order substantially in the form annexed hereto as **Exhibit A** (the "Interim Order") and a final order substantially in the form annexed hereto as **Exhibit B** (the "Final Order") (i) authorizing the Debtors to pay certain prepetition taxes in the ordinary course of business, and (ii) authorizing banks and financial institutions to honor and process checks and transfers related thereto. In support of the Motion, the Debtors, in Support of First Day Relief (the "First Day Declaration") filed contemporaneously herewith, and respectfully submit as follows:

JURISDICTION AND VENUE

- 1. The Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334 and the *Amended Standing Order of Reference of the United States District Court for the District of Delaware*, dated February 29, 2012. This is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2), and the Debtors confirm their consent pursuant to Rule 9013–1(f) of the Local Rules of Bankruptcy Practice and Procedure of the United States Bankruptcy Court for the District of Delaware (the "Local Rules") to the entry of a final order by the Court in connection with this Motion to the extent that it is later determined that the Court, absent consent of the parties, cannot enter final orders or judgments in connection herewith consistent with Article III of the United States Constitution.
- Venue of these proceedings and the Motion in this Court is proper under
 U.S.C. § 1408 and § 1409.
- 3. The statutory and rule bases for the relief requested herein are sections 105(a), 363, 507(a)(8) and 541 of the Bankruptcy Code and Rule 6003 and 6004 of the Bankruptcy Rules.

BACKGROUND

- 4. On the date hereof, (the "<u>Petition Date</u>"), the Debtors commenced their bankruptcy cases by filing voluntary petitions for relief under chapter 11 of the Bankruptcy Code (the "<u>Chapter 11 Cases</u>"). No trustee, examiner or creditors' committee has been appointed in these cases. The Debtors are operating their respective businesses as debtors-in-possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.
- 5. The events leading up to the Petition Date and the facts and circumstances supporting the relief requested herein are set forth in the First Day Declaration.

RELIEF REQUESTED

6. By this Motion, the Debtors seek the entry of the Interim and Final Orders, pursuant to sections 105(a), 363, 507(a)(8) and 541 of the Bankruptcy Code, authorizing, but not directing, the Debtors to pay any Taxes (each as defined below) that, in the ordinary course of business, accrued or arose prior to the Petition Date. The Debtors seek authorization to pay any Taxes (including amounts paid prepetition by checks that have not yet cleared as of the Petition Date) on an interim basis up to an aggregate amount of \$1,500,000, and on a final basis up to \$3,000,000.²

7. Additionally, to the extent any check issued or electronic transfer initiated prior to the Petition Date for the purpose of satisfying any prepetition obligation on account of Taxes has not cleared the Debtors' bank accounts as of the Petition Date, the Debtors request the Court to authorize the Debtors' banks, when requested by the Debtors in the Debtors' sole discretion (but subject to and in accordance with any orders authorizing postpetition financing and the use of cash collateral and the applicable budget thereunder), to receive, process, honor and pay such checks or electronic transfers initiated prior to the Petition Date, provided that there are sufficient funds available in the applicable accounts to make such payments. The Debtors also seek authorization to issue replacement checks or to provide for other means of payment to the extent necessary to pay such Taxes.

^{2.} Nothing in this Motion shall be deemed to constitute an admission by the Debtors to any asserted liability or obligation with respect to any Taxes. The Debtors reserve any and all rights to contest any Taxes asserted against them by any of the Authorities (as defined below). Likewise, if the Court grants the relief sought herein, any payment made pursuant to the Court's order is not intended and should not be construed as an admission as to the validity of any claim or a waiver of the Debtors' rights to subsequently dispute such claim.

THE DEBTORS' TAX OBLIGATIONS

- 8. In the ordinary course of business, the Debtors (i) incur taxes including, without limitation, value added taxes (the "<u>VAT</u>"), property taxes (the "<u>Property Taxes</u>"), income taxes (the "<u>Income Taxes</u>"), and other miscellaneous taxes (together with the VAT Taxes, Property Taxes, and Income Taxes, the "<u>Taxes</u>")³⁴; and (ii) remit such Taxes to various taxing and other governmental authorities (collectively, the "<u>Authorities</u>") or make payments to various third parties, who, in turn, remit such Taxes to the Authorities. The Debtors pay the Taxes monthly, quarterly, annually, semiannually, biennially or triennially, in each case as required by applicable laws and regulations.
- 9. As explained more fully herein, the relief requested should be granted because, among other things, (i) certain Taxes may constitute "trust fund" taxes and thus are not property of the Debtors' estates; (ii) the failure to pay certain Taxes could result in a lien being placed on the Debtors' property; and (iii) certain Taxes may constitute priority claims. The failure to pay the Taxes could disrupt the Debtors' operations and impair the Debtors' efforts to maximize the value of their assets for their stakeholders. Accordingly, payment of the Taxes is in the best interests of the Debtors' estates.

^{3.} For the avoidance of doubt, the Taxes do not include any amounts related to the Mexican Tax Assessment, as defined below.

^{4.} The Debtors are required by law to withhold from employee wages amounts related to federal, state, local and foreign income taxes, social security and Medicare taxes, and other taxes imposed by applicable law for remittance to the appropriate federal, state, local or non-U.S. taxing authority (the "Payroll Taxes"). The Debtors typically pay payroll in 1-2 months in arrears. As of the Petition Date, the Debtors owe approximately \$2,500,000 in Payroll Taxes. The Debtors are separately seeking relief to pay Payroll Taxes in their Motion for Entry of Interim and Final Orders (A) Authorizing Debtors To Pay (I) Prepetition Employee Obligations, (ii) Prepetition Withholding Obligations, and (iii) Postpetition Employee Obligations in the Ordinary Course, and (B Authorizing Banks To Honor Related Transfers.

$\overline{\mathbf{VAT}}$

Debtors collect and remit value-added tax ("VAT") to the relevant taxing authorities on the sale of its services. The Debtors typically remit amounts for VAT in arrears for the previous month, with payments occurring typically several weeks after accrual. As of the Petition Date, the Debtors estimate that they do not owe any VAT amounts. The Debtors request authority to satisfy any amounts owed on account of VAT that are presently or may become due and owing in the ordinary course of business during these Chapter 11 cases.

PROPERTY TAXES

11. The Debtors are required to pay Property Taxes to relevant Authorities in the ordinary course of operating their businesses. The Debtors generally remit Property Taxes directly to Authorities or for "pass-through" Property Taxes under lease agreements. The Debtors generally pay Property Taxes as they accrue or on a monthly, quarterly, or annual basis. As of the Petition Date, the Debtors are not presently aware of any Property Taxes that may be owed for the fiscal year 2023, but certain Property Taxes may be billed during the pendency of these Chapter 11 Cases. The Debtors request authority to satisfy any amounts owed on account of Property Taxes that are presently or may become due and owing in the ordinary course of business during these Chapter 11 Cases.

INCOME TAXES

12. The Debtors pay Income Taxes to federal, state and local taxing authorities in the ordinary course of business. The Debtors 2022 US federal and state income tax returns were extended until October 15, 2023 and have not yet been filed. While the Debtors are still preparing their 2022 tax returns, the Debtors estimate that they may owe approximately \$65,000 in 2022

state Income Taxes in the U.S. that will need to be paid when they file their 2022 tax returns in October 2023. In connection with an amended tax return, the Debtors also estimate that they owe approximately \$101,000 with respect to an amended 2019 Federal Income Tax Return. For locations outside the US, the Debtors estimate that there is approximately \$211,700 in Income Tax prepayments that are due and owing on account of the months of August, September, and October of this year. The Debtors request authority to satisfy any amounts owed on account of Income Taxes that are presently or may become due and owing in the ordinary course of business during these Chapter 11 Cases.

SERVICE TAXES

13. In Brazil, the Debtors must pay a municipal tax on the services they provide, and the amount of the tax is based on the amount of revenue derived from those services ("Revenue Taxes"). The Debtors are also subject to a withholding tax in Brazil on account of the services that they receive, including utilities (together with Revenue Taxes, "Service Taxes"). The Debtors pay Service Taxes on a quarterly basis. The Debtors estimate that they owe approximately \$85,818 in Service Taxes.

FRANCHISE & EXCISE TAXES

14. In the US, the Debtors are subject to a franchise tax in the state of Delaware, and both a franchise and excise tax in Tennessee ("<u>Franchise and/or Excise Taxes</u>"). The Debtors believe that they will owe approximately \$80,000 on account of an estimated Delaware Franchise Taxes for the last two quarters of 2023. The Debtors also owe approximately \$684,600 in Tennessee Franchise and Excise Taxes due from 2018, which amount includes tax, penalties and interest.

MEXICAN TAX ASSESSMENT

- On August 2, 2021, the Mexican Tax Administration Service (Servicio de 15. Administración Tributaria) (the "Mexican Tax Authority") issued a tax assessment against Debtors AT Digital Solutions, formerly known as North American Software, S.A.P.I. de C.V., and Anzen Soluciones, S.A. de C.V. ("Anzen" and together with AT Digital Solutions, the "Mexican Tax Entities") for income tax, VAT tax, and employees profit sharing payables, totaling an aggregate amount of \$3,373,018,857 Mexican pesos (the "Mexican Tax Assessment"). Using an end of July 2023 conversion rate of 16.7338, the Mexican Tax Assessment totaled approximately \$203,333,138.09 in U.S. dollars as of June 30, 2023, broken down as follows: an assessment for 2018 against AT Digital Solutions consisting of tax totaling \$108,311,640.72, interest totaling \$49,467,453.94, and penalties totaling \$43,790,115.99; an assessment for 2019 against AT Digital Solutions consisting of tax totaling \$859,672.91, interest totaling \$241,688.59, and penalties totaling \$443,711.98; and an assessment for 2019 against Anzen consisting of tax totaling \$122,804.24, interest totaling \$32,494, and penalties totaling \$63,555.73. Thus, the approximately US \$203 million Mexican Tax Assessment includes interest and penalties totaling approximately \$94 million, nearly half of its total amount.
- 16. The Debtors strongly contest the Mexican Tax Assessment and have taken steps to challenge it. On April 8, 2022, an appeal was filed before the Mexican Tax Authority an administrative appeal ("recurso de revocación") challenging the Mexican Tax Assessment, which was registered under file number RRL2022005645 (the "Administrative Appeal"), and assigned to the "Administración Desconcentrada Jurídica 2" for its processing and resolution. As of the Petition Date, no definitive ruling has been issued to the Administrative Appeal.

17. The Debtors are not seeking to pay any amounts on account of the Mexican Tax Assessment through this Motion.

BASIS FOR RELIEF

I. Payment of the Taxes is Necessary and Appropriate.

18. The Debtors' payment of Taxes in the ordinary course of business is justified because, among other things, (i) certain of the amounts held by the Debtors for Taxes are not property of the estate pursuant to section 541(d) of the Bankruptcy Code; (ii) the Debtors' directors and officers may be held personally liable for the nonpayment of the Taxes or certain Authorities could take precipitous action for such nonpayment, which would distract the Debtors from their efforts to reorganize; (iii) certain Taxes may constitute secured or priority claims; and (iv) such relief is warranted under the doctrine of necessity.

A. Certain of the Taxes May Not Be Property of the Estate

- 19. Section 541(d) of the Bankruptcy Code provides, in relevant part, that "[p]roperty in which the debtor holds, as of the commencement of the case, only legal title and not an equitable interest . . . becomes property of the estate under subsection (a)(1) or (2) of this section only to the extent of the debtor's legal title to such property, but not to the extent of any equitable interest in such property that the debtor does not hold." 11 U.S.C. § 541(d).
- 20. To the extent the Debtors have collected any Taxes from third parties, such amounts may be held in trust for the benefit of the Authorities and are not property of the estates. *See, e.g., Begier v. I.R.S.*, 496 U.S. 53, 59 (1990) (holding that any prepetition payment of trust fund taxes is not a transfer subject to avoidance because such funds are not the debtor's property); *City of Farrell v. Sharon Steel Corp.*, 41 F.3d 92, 97 (3d Cir. 1994) (holding that income required to be withheld by city ordinance and state law is held "in trust" for the taxing authority); *DiChiaro*

v. N.Y. State Tax Comm'n, 760 F.2d 432, 433-34 (2d Cir. 1985) (holding that a sales tax that is required by state law to be collected by sellers from their customers is a "trust fund" tax); In re Megafoods Stores, Inc., 163 F.3d 1063, 1067-68 (9th Cir. 1998); In re Al Copeland Enters., Inc., 991 F.2d 233, 237 (5th Cir. 1993); In re Equalnet Commc'ns Corp., 258 B.R. 368, 370 (Bankr. S.D. Tex. 2000) ("[C]ertain prepetition tax claims, such as sales taxes, could be trust fund claims."). The Debtors submit that certain Taxes, such as VAT collected from customers, likely constitute "trust fund" taxes. Since the Debtors' estates would have no equitable interest in such "trust fund" Taxes, they seek the relief requested herein in order to pay such amounts to the relevant Authorities.

B. Payment of the Taxes Will Avoid Unnecessary Distractions in These Chapter 11 Cases

21. Any regulatory dispute or delinquency that affects the Debtors' ability to conduct business could have a wide-ranging and adverse impact on the Debtors' operations as a whole. Specifically, the Debtors' failure to pay the Taxes could adversely affect their business operations because, among other things: (i) the Authorities could audit the Debtors or distract the Debtors from continuing their businesses, which, even if unsuccessful, would unnecessarily divert the Debtors' attention from the sale process that is the centerpiece of these Chapter 11 Cases; (ii) the Authorities could attempt to suspend the Debtors' operations, file liens, seek to lift the automatic stay and pursue other remedies that will harm the estates; and (iii) in many states, officers and directors of a debtor may be held personally liable even if a failure to pay such Taxes is not a result of their own malfeasance, which would undoubtedly distract those key officers and directors from their duties when their immediate and full-time attention to should be directed towards the Debtors' efforts to reorganize. It is in the best interest of the Debtors' estates to eliminate the possibility of such time-consuming and potentially damaging distractions.

C. Certain of the Taxes May Constitute Secured or Priority Claims Entitled to Special Treatment Under the Bankruptcy Code

22. Additionally, it is likely that some of the Taxes are entitled to priority status under the Bankruptcy Code. *See* 11 U.S.C. § 507(a)(8). If the Taxes are deemed to be entitled to priority status, section 1129(a)(9)(C) requires that they be paid through regular installment payments (i) of a total value, as of the effective date of the plan, equal to the allowed amount of each such claim; (ii) over a period not exceeding five (5) years after the Petition Date; and (iii) in a manner no less favorable than the most favored nonpriority claim⁵ provided for by the Debtors' chapter 11 plan, if any. *See* 11 U.S.C. § 1129(a)(9)(C). The Debtors expect to pay priority claims in full. Accordingly, the Debtors' payment of the Taxes at this juncture would only affect the timing of the payments and would reduce the amount of Taxes owed if later paid under a plan (due to the high interest rates and late fees attributable to delinquent payments). Therefore, other creditors and parties-in-interest would not be prejudiced if the relief sought herein were granted by this Court.

D. Payment of the Taxes is Warranted Under the Doctrine of Necessity

23. The Court may authorize the Debtors to pay any prepetition amounts related to Taxes pursuant to section 363(b) of the Bankruptcy Code. Section 363 provides that "[t]he trustee, after notice and a hearing, may use, sell, or lease, other than in the ordinary course of business, property of the estate." 11 U.S.C. § 363(b)(1). Under this section, a court may authorize a debtor to pay certain prepetition claims where a sound business purpose exists for doing so. *See In re Ionosphere Clubs, Inc.*, 98 B.R. 174, 175 (Bankr. S.D.N.Y. 1989) (finding that a sound business purpose existed to justify payment of prepetition wages); *see also Armstrong World*

^{5.} Other than a convenience class under section 1122(b).

Indus., Inc. v. James A. Phillips, Inc. (In re James A. Phillips, Inc.), 29 B.R. 391, 397 (S.D.N.Y. 1983) (relying on section 363 to allow contractor to pay prepetition claims of suppliers who were potential lien claimants because the payments were necessary for general contractors to release funds owed to debtors); In re Friedman's Inc., No. 09-10161, 2011 WL 5975283, at *1 (Bankr. D. Del. Nov. 30, 2011) (approving the payment of prepetition staffing services pursuant to section 363 to avoid an "epidemic of [e]mployee departures" and "deterioration in morale"). Here, the Debtors' failure to pay the Taxes could have a material adverse impact on their ability to operate in the ordinary course, as the Authorities could attempt to prevent or delay the Debtors' operations if the Taxes are not paid.

- 24. The payment of Taxes is likewise authorized by section 105(a) of the Bankruptcy Code, which provides that "[t]he court may issue any order, process, or judgment that is necessary or appropriate to carry out the provisions of [title 11]." 11 U.S.C. § 105(a). Thus, section 105(a) essentially codifies the Court's inherent equitable powers. Specifically, the Court may use its power under section 105(a) to authorize payment of prepetition obligations pursuant to the "doctrine of necessity" (also referred to as the "necessity of payment" rule).
- 25. The United States Court of Appeals for the Third Circuit recognizes this doctrine. See, e.g., In re Lehigh & New England Ry. Co., 657 F.2d 570, 581 (3d Cir. 1981). In Lehigh, the Third Circuit held that a court could authorize the payment of prepetition claims if such payment were essential to the continued operation of the debtor. See id. (stating courts may authorize payment of prepetition claims when there "is the possibility that the creditor will employ an immediate economic sanction, failing such payment"); see also In re Penn Central Transp. Co., 467 F.2d 100, 102 (3rd Cir. 1972) (holding doctrine of necessity permits "immediate payment of claims of creditors where those creditors will not supply services or material essential to the

conduct of the business until their pre-reorganization claims have been paid"); *In re Just for Feet, Inc.*, 242 B.R. 821, 824-45 (Bankr. D. Del. 1999) (noting that, in the Third Circuit, debtors may pay prepetition claims that are essential to continued operation of their businesses); *In re Columbia Gas Sys., Inc.*, 171 B.R. 189, 191-92 (Bankr. D. Del. 1994) (same).

- 26. Relief similar to that requested herein has been consistently granted by courts in this district. See, e.g., In re Stanadyne LLC, No. 23-10207 (Bankr. D. Del. April 14, 2023), ECF No. 181; In re Kabbage, Inc. d/b/a KServicing, No. 22-10951 (Bankr. D. Del. Oct. 21, 2022), ECF No. 133; In re TPC Group Inc., No. 22-10493 (Bankr. D. Del. June 30, 2022), ECF No. 342; In re American Eagle Delaware Holding Co., No. 22-10028 (Bankr. D. Del. Feb. 7, 2022), ECF No. 97; In re Nine Point Energy Holdings, Inc., No. 21-10570 (Bankr. D. Del. Apr. 6, 2021), ECF No. 195.
- 27. Payment of the Taxes will enable the Debtors to operate their businesses without the needless disruption of potential litigation initiated by one or more of the Authorities or disputes under section 362(b)(4) concerning enforcement of the Authorities' police and regulatory powers. In light of the foregoing, the Debtors submit that the present circumstances warrant relief in these Chapter 11 Cases similar to that set forth above, in order to preserve the Debtors' assets and avoid business interruption.

II. Cause Exists to Authorize the Debtors' Financial Institutions to Honor Checks and Electronic Fund Transfers.

28. The Debtors have sufficient funds to pay the amounts described herein in the ordinary course of business by virtue of expected cash flows from ongoing business operations, anticipated postpetition financing and access to use of their cash collateral. Additionally, under the Debtors' existing cash management system, the Debtors represent that checks or electronic payment requests can be readily identified as relating to an authorized payment in respect of the

Taxes. Accordingly, the Debtors believe that checks or electronic payment requests, other than those relating to authorized payments, will not be honored inadvertently and that all applicable financial institutions should be authorized, when requested by the Debtors, to receive, process, honor and pay any and all checks or electronic payment requests in respect of the Taxes to the extent that there are sufficient funds in the applicable accounts to make such payments. Moreover, pursuant to the proposed order, all applicable banks and other financial institutions shall not have any liability in connection with honoring any prepetition checks or electronic payment requests contemplated by the proposed order and/or designated by the Debtors.

THE MOTION SATISFIES BANKRUPTCY RULE 6003

29. Pursuant to Bankruptcy Rule 6003(b), a court shall not grant "a motion to pay all or part of a claim that arose before the filing of the petition" within twenty-one days of the petition date "[e]xcept to the extent that relief is necessary to avoid immediate and irreparable harm." Fed. R. Bankr. P. 6003(b). As described herein and in the First Day Declaration, the Debtors' business operations rely heavily on current payment of the Taxes. The failure to pay the Taxes would have immediate and detrimental consequences to the Debtors' business operations and would decrease the value of the Debtors' estates to the detriment and prejudice of all stakeholders. Accordingly, the Debtors submit that the requirements of Bankruptcy Rule 6003 have been met and that the relief requested in the Motion is necessary to avoid immediate and irreparable harm to the Debtors and their estates.

WAIVER OF BANKRUPTCY RULE 6004(h)

30. The Debtors further seek a waiver of any stay of the effectiveness of the order approving this Motion. Pursuant to Bankruptcy Rule 6004(h), "[a]n order authorizing the use, sale, or lease of property other than cash collateral is stayed until the expiration of 14 days after entry of the order, unless the court orders otherwise." Fed. R. Bankr. P. 6004(h). As stated

above, paying the Taxes will be necessary to prevent irreparable damage to the Debtors' business operations and, therefore, the value of the Debtors' businesses. Accordingly, the Debtors submit that ample cause exists to justify a waiver of the fourteen-day stay imposed by Bankruptcy Rule 6004(h), to the extent it applies.

RESERVATION OF RIGHTS

31. Nothing contained herein is intended or should be construed as an admission of the validity of any claim against the Debtors, a waiver of the Debtors' rights to dispute any claim, or an approval or assumption of any agreement, contract or lease under section 365 of the Bankruptcy Code. The Debtors expressly reserve their rights to contest any assertion to the contrary and any objection to the relief sought in this Motion under any grounds available to the Debtors in accordance with applicable non-bankruptcy law.

NOTICE

32. Notice of the hearing on this Motion shall be provided to (i) the Office of the United States Trustee for the District of Delaware; (ii) the Authorities; (iii) counsel for the DIP Agent; (iv) counsel for the prepetition secured lenders; (v) those parties listed on the list of creditors holding the twenty largest unsecured claims against the Debtors (on a consolidated basis), as identified in their chapter 11 petitions; and (vi) all the parties that have requested notice in this proceeding pursuant to Bankruptcy Rule 2002. Notice of this Motion and any order entered hereon will be served in accordance with Rule 9013-1(m). The Debtors submit that, in light of the nature of the relief requested, no other or further notice need be given.

NO PRIOR REQUEST

33. No prior request for the relief sought in the Motion has been made to this Court or any other court.

WHEREFORE, the Debtors respectfully request that the Court grant the relief

requested herein and such other or further relief as the Court deems just and proper.

- 7. Nothing in this Order or the Motion is intended or should be construed as (i) an admission as to the validity or priority of any claim against the Debtors, (ii) a waiver of the Debtors' rights to dispute any claim, including the validity or priority thereof, or (iii) an approval, assumption or reaffirmation of any agreement, contract or lease whether under section 365(a) of the Bankruptcy Code or otherwise. Likewise, any payment made pursuant to this Order is not intended and should not be construed as an admission as to the validity or priority of any claim or a waiver of the Debtors' rights to subsequently dispute such claim.
