PLEASE TAKE FURTHER NOTICE that, on September 25, 2023, the Court entered the Order (I) Scheduling a Hearing on the Approval of the Sale of All or Substantially All of the Debtors' Assets Free and Clear of All Encumbrances Other Than Assumed Liabilities and Permitted Encumbrances, and the Assumption and Assignment of Certain Executory Contracts and Unexpired Leases, (II) Approving Certain Bidding Procedures, and Assumption and Assignment Procedures, and the Form and Manner of Notice Thereof, and (III) Granting Related Relief [Docket No. 132] (the "Bidding Procedures Order"), which approved the timeline for the sale of the Debtors' assets.

PLEASE TAKE FURTHER NOTICE that, on October 10, 2023, the Court entered the Order Approving (I) the Debtors' Entry into the Stalking Horse APA, (II) Expense Reimbursement for Stalking Horse Bidder, and (III) Granting Related Relief [Docket No. 233].

PLEASE TAKE FURTHER NOTICE that, on November 15, 2023, after not receiving any additional qualified bids, in accordance with the Bidding Procedures Order, the Debtors filed the *Notice of Designation of Successful Bidder and Cancellation of Auction* [Docket No. 432], announcing the designation of the stalking horse bidder, AT Holdings Corp. (the "Purchaser"), as the successful bidder for the Acquired Assets (as defined in the APA (defined below)).

PLEASE TAKE FURTHER NOTICE that, on December 28, 2023, the Court entered the Order (I) Approving the Sale of Assets Free and Clear of Liens, Claims, Interests and Encumbrances, (II) Approving the Assumption and Assignment of Executory Contracts and Unexpired Leases in Connection Therewith and (III) Granting Related Relief [Docket No. 590] (the "Sale Order"), which approved the Debtors' sale of Acquired Assets to the Purchaser pursuant to the asset purchase agreement attached thereto as Exhibit 1 (as amended, the "APA").

PLEASE TAKE FURTHER NOTICE that the APA contemplates at least two Closings (as defined in the APA) relating to the sale of the Acquired Assets to the Purchaser.

PLEASE TAKE FURTHER NOTICE that, on December 31, 2023, the first Closing (the "First Closing") of the sale of certain of the Acquired Assets to the Purchaser closed.

PLEASE TAKE FURTHER NOTICE that on January 3, 2024, the Debtors filed the Notice of (I) First Closing of Sale of the Debtors' Assets and (II) Filing of Schedules of Assigned Contracts for First Closing [Docket No. 602].

PLEASE TAKE FURTHER NOTICE that, on April 12, 2024, the second closing (the "Second Closing") of the sale of certain of the Acquired Assets to the Purchaser closed.

PLEASE TAKE FURTHER NOTICE that, in accordance with the APA, while the Debtors have transferred some of the Mexican Delayed Assets and some of the Mexican Delayed Liabilities, the Mexican Delayed Closing (as defined in the APA) has not been completed.

PLEASE TAKE FURTHER NOTICE that the schedule of Assigned Contracts (as defined in the APA) for the Second Closing is attached hereto as **Exhibit A**.

PLEASE TAKE FURTHER NOTICE that the Debtors and Purchaser reserve all rights to designate additional executory contracts and unexpired leases for assumption and assignment in connection with the Mexican Delayed Closing and any other Closing that may occur in connection with the APA.
