- 1. I am employed by Kurtzman Carson Consultants LLC ("KCC"), the claims, noticing and administrative agent for the Debtors in the above-captioned cases.  Consultants LLC as Noticing Agent Nunc Pro Tunc to May 6, 2019 [Docket No. 292].
