The Debtors in these chapter 11 cases (the "Chapter 11 Cases"), along with the last four digits of each Debtor's federal tax identification number, are Northwest Senior Housing Corporation (1278) and Senior Quality Lifestyles Corporation (2669) (together, the "Debtors"). HEARING ON SUCH NOTICE OR MOTION IS TIMELY REQUESTED, THE RELIEF REQUESTED SHALL BE DEEMED TO BE UNOPPOSED, AND THE COURT MAY ENTER AN ORDER GRANTING THE RELIEF SOUGHT OR THE NOTICED ACTION MAY BE TAKEN.

NOW COMES, Stephen A. McCartin, the Trustee of the Edgemere Resident's Trust (the "Trustee"), and files this *First Omnibus Objection to Resident Claims* (the "Objection"), and requests entry of an order, substantially in the form attached hereto as <u>Exhibit</u> <u>A</u> (the "Proposed Order"), sustaining the Objection to the disputed claims (each, a "Disputed Claim") listed on <u>Exhibit 1</u> to the attached Proposed Order.² In support of the Objection, the Trustee respectfully represents as follow:

I. JURISDICTION AND VENUE

- 1. The United States Bankruptcy Court for the Northern District of Texas (the "Court") has jurisdiction over this matter pursuant to 28 U.S.C. § 1334. This matter is a core proceeding within the meaning of 28 U.S.C. § 157(b). The Trustee confirms his consent, pursuant to Rule 7008 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), to the entry of a final order by the Court.
 - 2. Venue is proper pursuant to 28 U.S.C. §§ 1408 and 1409.
- 3. The bases for the relief requested herein are section 502 of title 11 of the United States Code (the "Bankruptcy Code"), Bankruptcy Rule 2014 and 2016, and Rule 3007-2 of the Local Bankruptcy Rules of the United States Bankruptcy Court for the Northern District of Texas (the "Local Rules").

For the sake of completeness and as alternative bases to support the Objection, certain Disputed Claims may be listed in more than one of the exhibits attached to the Proposed Order.

II. BACKGROUND

- 4. On April 14, 2022 (the "Petition Date"), each of the Debtors filed a voluntary petition for relief under Chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the Northern District of Texas (the "Court"), commencing the above-captioned cases (the "Chapter 11 Cases").
- 5. On April 7, 2023, the Court entered Findings of Fact, Conclusions of Law, and Order Confirming Chapter 11 Plan of Plan Sponsors [Docket Nos. 1393, 1394] (the "Confirmation Order"), confirming the Fourth Amended Chapter 11 Plan of the Plan Sponsors Dated February 17, 2023 [Docket No. 1241] (the "Plan").
- 6. On May 22, 2023, the Debtors gave notice of the selection of the Residents Trustee pursuant to the Plan, who will be responsible for, *inter alia*, reconciling and otherwise resolving resident related proofs of claim (collectively, the "**Proofs of Claim**") that have been filed in these Chapter 11 Cases. *See* Docket Nos. 1504 and 1526. Those Proofs of Claim include at least 78 Proofs of Claim related to refund claims of current and former residents of Edgemere (collectively, the "**Residents' Claims**").

III. PROOFS OF CLAIMS

7. More than seventy-eight (78) resident related refund claims have been filed in these Chapter 11 Cases. The Residents' Trust is in the process of reviewing and reconciling these filed proofs of claim. This process includes identifying particular categories of claims that may be targeted for disallowance, reduction and allowance, or reclassification. To avoid possible double recovery or improper recovery by claimants, the Residents' Trust anticipates filing objections to these categories of claims.

8. As part of its ongoing review, the Residents' Trust has reviewed the proofs of claim listed on Exhibit 1 attached to the Proposed Order, and has concluded that each such claim is objectionable on the basis set forth below.

IV. OBJECTIONS AND RELIEF REQUESTED

A. Priority Claims.

9. By this Objection, the Residents' Trust seeks entry of the Proposed Order, pursuant to section 502(b) of the Bankruptcy Code and Bankruptcy Rule 3007(d)(2), disallowing the priority status of each Proof of Claim listed on **Exhibit 1** to the Proposed Order, and requests this Court enter an order allowing the claims in the Proposed Allowed Amounts listed on Exhibit 1 to the Proposed Order as general unsecured claims only.

B. Secured Claims.

10. By this Objection, the Residents' Trust seeks entry of the Proposed Order, pursuant to section 502(b) of the Bankruptcy Code and Bankruptcy Rule 3007(d)(4), disallowing the secured status of each Proof of Claim listed on **Exhibit 1** to the Proposed Order, and requests this Court enter an order allowing the claims in the Proposed Allowed Amounts listed on Exhibit 1 to the Proposed Order as general unsecured claims only.

C. Claims in Excess of Scheduled Amounts.

11. By this Objection, the Residents' Trust seeks entry of the Proposed Order, pursuant to section 502(b) of the Bankruptcy Code and Bankruptcy Rule 3007(d)(7), disallowing each Proof of Claim listed on **Exhibit 1** to the Proposed Order, in the amounts claimed in excess of the Proposed Allowed Amounts (the amounts scheduled for such claims of the Debtors' Schedules of Assets and Liabilities), and requests this Court enter an order allowing such claims in the Proposed Allowed Amounts as general unsecured claims.

D. Duplicate and Escrow Related Claims.

12. By this Objection, the Residents' Trust seeks entry of the Proposed Order, pursuant to section 502(b) of the Bankruptcy Code and Bankruptcy Rule 3007(d)(7), disallowing in full the duplicate claims and resident escrow related claims (which have been paid in full) as indicated as duplicated or escrow claims on Exhibit 1 to the Proposed Order.

V. RESERVATION OF RIGHTS

13. Nothing herein shall constitute an admission of liability by the Debtors or the Residents' Trust with respect to any Proof of Claim. The Residents' Trust reserves its right to object to any Proof of Claim, including any claim listed on **Exhibit 1** to the Proposed Order, on any grounds whatsoever at a later date.

WHEREFORE, the Residents' Trust respectfully requests that the Court enter the Proposed Order, substantially in the form attached hereto as **Exhibit A**, granting the relief requested herein, and for such other relief as the Court deems appropriate under the circumstances.

- 1. The Objection is sustained as set forth herein.

Each Disputed Claim identified on <u>Exhibit 1</u> attached to this Order is allowed in the Proposed Allowed Amount of such claim on Exhibit 1, as a general unsecured claim only, and is disallowed as a priority and secured claim and disallowed in any amount exceeding the Claim Amounts on Exhibit 1.
- 4. Each Disputed Claim identified on Exhibit 1 attached to the Order as a duplicate or escrow related deposit claim is disallowed in full.
- 5. KCC, as claims and noticing agent, is authorized and directed to update the claims register maintained in these Chapter 11 Cases to reflect the relief granted in this Order.
- 6. Notwithstanding the relief granted in this Order and any actions taken pursuant to such relief, nothing in this Order shall be deemed: (a) an admission as to the validity of any prepetition claim against a Debtor entity; (b) a waiver of any parties right to dispute any prepetition claim on any grounds; (c) a promise or requirement to pay any prepetition claim; (d) an implication or admission that any particular claim is of a type specified or defined in this Objection or any order granting the relief requested by this Objection; (e) a request or authorization to assume any prepetition agreement, contract, or lease pursuant to section 365 of the Bankruptcy Code; or (f) a waiver of any parties rights under the Bankruptcy Code or any other applicable law.

- 7. Notice of the Objection as provided therein shall be deemed good and sufficient and the requirements of the Bankruptcy Local Rules are satisfied by such notice.
- 8. Notwithstanding any Bankruptcy Rule to the contrary, the terms and conditions of this Order are immediately effective and enforceable upon its entry.
- 9. The Residents' Trust is authorized to take all actions necessary to effectuate the relief granted in this Order in accordance with the Objection.
- 10. This Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, and enforcement of this Order.
