25 **PLEASE TAKE NOTICE** that a Hearing will be held on May 22, 2024 at 10:30 a.m., or
26 as soon thereafter as the matter can be heard, at the United States Bankruptcy Court at 1300 Clay
Street, Oakland, California, Courtroom 220 before the Honorable William J. Lafferty, United States
27 Bankruptcy Judge, to consider the *Motion to Allow Filing of Late Proof of Claim* (the "Motion"),
filed concurrently herewith, by a claimant who is a sexual abuse claimant that holds a claim against
28 the Debtor. (hereinafter the "Claimant No. 552"). The Motion seeks an order allowing the filing



1 of late proof of claim on behalf of Claimant No. 552 based upon excusable neglect under the
2 provisions of Federal Rule of Bankruptcy Procedure 9006(b)(1).

3 The Motion is based upon this Notice, the Motion and the memorandum of points and
4 authorities set forth therein, the Declarations of Terry Gross and Mary Parker in Support of the

18 Oakland, California 94604) and must be served on counsel for Claimant No. 552 at the address
19 listed above. **Unless a timely objection is filed, the Court may grant the relief requested in the**
20 **Motion without a hearing. Failure to file and serve a timely objection may result in waiver**
21 **of any objection.**
