# ORDER SETTING HEARING ON DEBTORS' MOTION FOR AN ORDER (A) (I) AUTHORIZING THE FORMATION OF A COMMITTEE OF RETIRED EMPLOYEES PURSUANT TO SECTIONS 1114(C)(2) AND 1114(D) OF THE BANKRUPTCY CODE, AND (II) ESTABLISHING PROCEDURES FOR SELECTING COMMITTEE MEMBERS AND (B) GRANTING RELATED RELIEF

1. The Motion is GRANTED to the extent provided herein.

2. The Section 1114 Motion is hereby set for hearing on July 28 at 10:00 a.m. in Courtroom 3 located at the United States Bankruptcy Court for the Northern District of Alabama, Robert S. Vance Federal Building, 1800 Fifth Avenue North Birmingham, Alabama 35203, and the notice periods for the hearings on the foregoing motions are reduced accordingly.

3. The Debtors, proposed counsel for the Debtors, or any other agent for the Debtors, shall provide notice of such hearing by serving a copy of this Order on the service list identified in the Section 1114 Motion.

4. This Court shall retain jurisdiction with respect to all matters arising from or related to the implementation or interpretation of this Order.
